**TRAINING ACTIVITIES ON AML/CFT**  
**CALL FOR EXPRESSION OF INTEREST**

## **Introduction**

The consortium of the project LIGHT has published a call for expression of interest with an aim to establish a list of lawyers and notaries who may be invited to join the training activities organised in the framework of the project.

## **Project Background**

The LIGHT project aims at increasing the competency of lawyers and notaries in AML/CFT, therefore strengthening their role in the implementation of AML/CFT and ensuring the effectiveness of AML/CFT policy. The selected lawyers and notaries will have enhanced their functional competency in AML/CFT through four main competence profiles, which will let training participants:

- Acquire experimental insight and knowledge in EU Law on AML/CFT;
- Improve their capacity in ML/FT risk assessment;
- Perform AML/CFT reporting obligations;
- Analyse business relationships without intermediates as required by the Commission.

## **The Consortium**

Led by Conprofessioni (Italian Confederation of Liberal Professions), seven partners from four countries with a multifaceted nature and a common interest in AML/CFT: Association for Women Lawyers (from Bulgaria), European Council of the Liberal Professions (from Belgium), Federnotai (the Italian Federation of Notaries' Associations), UINL – International Union of Notaries, the Spanish General Council of Notaries and the General Council of Spanish Lawyers

aim at improving the understanding the competency of legal professions in AML/CFT via specific training activities targeting lawyers and notaries. These partners have been awarded an action grant to support transnational projects on judicial training covering civil law, criminal law or fundamental rights (JUST-JTRA-EJTR-AG-2020).

### **Description of the training activities**

The selected lawyers and notaries shall participate in the training activities (online and face-to-face seminars) organized in the framework of the project, as described below.

### **Online essential education on EU AML/CFT**

Individual E-Learning (async model) will be provided together with testing procedures so that participants will be ready to take part in transnational seminars. A test at the end of each session will certify the attendance.

<b>Participation</b>	240 lawyers and notaries

Four transnational seminars will cover all subjects identified by the training need analysis: to exploit the cross-border nature of ML/FT to share a common vision and modus operandi in EU AML/CFT.

### **Selection Criteria**

The project consortium shall select lawyers and notaries to join the training activities organized in the framework of the project.

The selection will be based on the following criteria:

- Eligibility of the application (that is, compliance with the provisions set out in this call);
- Lawyers and notaries from the countries involved in the project (Belgium, Bulgaria, Italy, Spain);
- Knowledge of English;
- Experience in the field of AML/CFT.
- A final test is planned at the end of the online trainingIts succesful completion is a condition to join the face-to-face seminars.

The deadline for applications is **24/10/2021**.
